Call for Abstracts

The regional migration conference on "Reversing the brain drain through the Scientific Diaspora in the Western Balkans" aims to provide an original contribution in the field of migration studies since almost all the countries in the region are characterized by a very high intensity of migratory processes mostly consisted of talented young people and with university education. One of the main ways to minimize the negative consequences of brain drain is the use of scientific Diasporas in the socio-economic development of the countries of origin.

The conference will bring together a broad range of university researchers, policy makers, civil society and mass media representatives to discuss brain drain and the role of the scientific diaspora in the Western Balkans. The conference will create opportunities for cooperation between different actors and give a better perspective of the current scientific diaspora and brain drain situation in the Western Balkan countries. Moreover, it will serve as a great networking opportunity where organizations, networks, researchers, and policymakers from the Western Balkans with a focus on diaspora contribution to socio-economic development will expand regional cooperation. Speakers coming from the region and diaspora will be selected based on their professional background in order to increase the knowledge sharing and information on diaspora contribution to socio-economic development in the region.

Papers to be presented in the conference should focus on one or more of the following **topics**, but not limited to:

- · Diaspora and migration evidences in the WB
- · Diaspora Scientists: The challenges of engaging them
